Our institute follows the following procedure for plagiarism detection in research and publications

- Preparation of research paper by faculty/student
- The faculty/student submits the research paper to the respective head of the department
- The research paper is reviewed by the head of the department and forwarded to R & D cell
- R & D cell checked through the Urkund software (https://www.urkund.com/ Urkund software is offered by Anna University for approved research supervisors)
- Committee will submit the review report and the recommendation to be imposed.
- Changes and corrections are completed by students and faculty members as per the plagiarism report
- Finally report or research paper will proceed for submission or publication
